2 **Tohono O'odham Nation, namely:**



10 **of OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
11 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
12 **Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham**
13 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
14 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
15 **of the Act of June 18, 1934 (48 Stat. 984).**


