7	Department of Water Resources; and
8	WHEREAS, Dr. Selso Villegas is qualified to assume the position of Executive Director for the
9	Tohono O'odham Nation Department of Water Resources; and
10	WHEREAS, Dr. Selso Villegas has accepted the position and appointment upon approval of the
11	Tohono O'odham Legislative Council.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
13	approve the appointment of Dr. Selso Villegas as the Executive Director for the Tohono
14	O'odham Nation Department of Water Resources.
15	BE IT FINALLY RESOLVED that Dr. Selso Villegas shall serve at the pleasure of the Chairman of the
16	Tohono O'odham Nation.
17	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08^{TH} . Day
18	of <u>OCTOBER, 2008</u> at a meeting at which a quorum was present with a vote of <u>2,534.5</u> FOR; <u>-0-</u>
19	AGAINST; -0-NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section
20 21	2 (e) of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
22	Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23	Stat. 984).
