

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution #08-521, "Approving the San Xavier District Budget for the
Fiscal Year beginning on October 1, 2008 and ending September 30, 2009")**

RESOLUTION NO. 08-613

1 **WHEREAS, on September 11, 2008 the Tohono O'odham Legislative Council passed Resolution**
2 **#08-521 approving San Xavier District's FY 2009 Budget; and**

3 **WHEREAS, an error in the BE IT FINALLY RESOLVED clause of Resolution #08-521 clause was**
4 **discovered; and**

5 **WHEREAS, the language to the BE IT FINALLY RESOLVED clause in Resolution #08-521 reads "that**
6 **the above total amount will be derived from two sources gaming revenues in the**
7 **amount fo \$7,912,640.93 and San Xavier District general operating funds in the**
8 **amount of \$77,689.42"; and**

9 **WHEREAS, the figure identified coming out of the San Xavier District General Operating funds**
10 **was incorrectly recorded as \$77,689.42; and**

11 **WHEREAS, the correct amount that should have been identified as coming out of San Xavier**
12 **District's General Operating fund should have been \$77,698.42.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
14 **Resolution #08-521 changing the language to the BE IT FINALLY RESOLVED clause to**
15 **read, "that the above total amount will be derived from two sources gaming revenues**
16 **in the amount of \$7,912,640.93 and San Xavier District general operating funds in the**
17 **amount of \$77,698.42.00" totaling \$7,990,339.35.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day**
19 **of OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 2,089.8 FOR; -0-**
20 **AGAINST; 444.7 NOT VOTING; and [05]ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
22 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**




