8	amount of \$77,689.42"; and
9	WHEREAS, the figure identified coming out of the San Xavier District General Operating funds
10	was incorrectly recorded as \$77,689.42; and
11	WHEREAS, the correct amount that should have been identified as coming out of San Xavier
12	District's General Operating fund should have been \$77,698.42.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends
14	Resolution #08-521 changing the language to the BE IT FINALLY RESOLVED clause to
15	read, "that the above total amount will be derived from two sources gaming revenues
16	in the amount of \$7,912,640.93 and San Xavier District general operating funds in the
17	amount of \$77,698.42.00" totaling \$7,990,339.35.
