

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Accept the American Indians with Disabilities Vocational Rehabilitation Grant  
Award No. H250D080009)**

**RESOLUTION NO. 08-614**

1 **WHEREAS, the Tohono O'odham Nation has submitted a grant application and is awarded a 5-**  
2 **year grant in the amount of \$2,164,693.31 under the U.S. Department of Education**  
3 **Rehabilitation Services Administration's Section 121 (Vocational Rehabilitation**  
4 **Service Projects for American Indian with Disabilities) under P.L., 102-569**  
5 **Rehabilitation Act of 1973 as amended; and**

6 **WHEREAS, the grant notification number is H250D080009 for the performance period from**  
7 **October 1, 2009 through September 30, 2013; and**

8 **WHEREAS, services under the Tohono O'odham Nation Vocational Rehabilitation Program will**  
9 **be provided to eligible enrolled members of the Tohono O'odham Nation living on or**  
10 **near the Nation and other federally recognized American Indians living on the Nation**  
11 **with disabilities; and**

12 **WHEREAS, the Tohono O'odham Nation will contribute the required 10% match from the**  
13 **Department of Education budget, TON Scholarship Fund Budget and the General Cost**  
14 **Pool; and**

15 **WHEREAS, the Vocational Rehabilitation Program has developed the FY 2009 budget in amount**  
16 **of \$411,200.00 beginning October 1, 2008 through September 30, 2009 and was**  
17 **approved by the Tohono O'odham Legislative Council Resolution No. 08-301.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
19 **accepts the 5-year grant award in the amount of \$2,164,693.31 under the U.S.**  
20 **Department of Education Rehabilitation Services Administration's Section 121**  
21 **(Vocational Rehabilitation Services Project for American Indians with Disabilities) of**  
22 **the P.L. 102-569 Rehabilitation Act of 1973 as amended and received grant notification**  
23 **number H250D080009, the performance period of this grant covering from October**  
24 **1, 2009 through September 30, 2013.**


25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairman and any designated official to negotiate and execute the grant.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
28 **of OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [05]ABSENT, pursuant to the powers vested in the Council by Section**  
30 **1 (d)(2)(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**




