4	Nation's water code and the implementation of SAWRSA, preparation of regulations
5	for the water code, and providing written explanations of the water codes in common
6	English format; and
7	WHEREAS, funding for the attorney contract will be from the SAWRSA Trust Fund, budget account
8	number 21-2010 which has been established for water-related attorney contracts and
9	professional services under the Office of Attorney General; and
10	WHEREAS, the Domestic Affairs, Water Resources and Budget & Finance Committees have
11	reviewed the attorney contract with Steven Weatherspoon PLLC and recommend
12	approval by the Legislative Council.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
14	1. Approves the Attorney Contract with Steven Weatherspoon, PLLC, in the amount
15	of\$100,000.00 for the period October 1, 2008 to September 30, 2009, substantially
16	in the form attached hereto.
17	2. Funding for the Attorney Contract shall be from the SAWRSA trust fund, budget
18	account number 21-2010.
19	3. The Chairperson of the Nation is authorized and directed to execute the Attorney
20	Contract.
