3	in California involving the Nation's interests under the Indian Child Welfare Act; and
4	WHEREAS, the Attorney General has proposed an attorney contract with California Indian Legal
5	Services for Fiscal Year 2009, for the period October 1, 2008 to September 30, 2009, in
6	the amount of \$100,000; and
7	WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed the attorney
8	contract and recommend approval by the Legislative Council.
9	NOW THEREFORE, BE IT RESOLVED THAT:
10	1. The Tohono O'odham Legislative Council approves an Attorney Contract with
11	California Indian Legal Services in the amount of \$100,000 for Fiscal Year 2008,
12	for the period October 1, 2008 to September 30, 2009, substantially in the form
13	attached hereto.
14	2. Funding for the Attorney Contract shall be provided from the operating budget
15	of the Office of Attorney General.
16	3. The Chairperson of the Nation is authorized and directed to execute the Attorney
