

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract For FY2009 with California Indian Legal Services)**

RESOLUTION NO. 08-627

1 **WHEREAS, the Office of Attorney General continues to require the legal services of California**
2 **Indian Legal Services to represent the Tohono O'odham Nation in legal proceedings**
3 **in California involving the Nation's interests under the Indian Child Welfare Act; and**

4 **WHEREAS, the Attorney General has proposed an attorney contract with California Indian Legal**
5 **Services for Fiscal Year 2009, for the period October 1, 2008 to September 30, 2009, in**
6 **the amount of \$100,000; and**


7 **WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed the attorney**
8 **contract and recommend approval by the Legislative Council.**

9 **NOW THEREFORE, BE IT RESOLVED THAT:**

- 10 1. **The Tohono O'odham Legislative Council approves an Attorney Contract with**
11 **California Indian Legal Services in the amount of \$100,000 for Fiscal Year 2008,**
12 **for the period October 1, 2008 to September 30, 2009, substantially in the form**
13 **attached hereto.**
- 14 2. **Funding for the Attorney Contract shall be provided from the operating budget**
15 **of the Office of Attorney General.**
- 16 3. **The Chairperson of the Nation is authorized and directed to execute the Attorney**
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
19 **of OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 2,362.5 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 172.0[06]ABSENT, pursuant to the powers vested in the Council by**
21 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**


