

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY2009 with the Law Firm of Yoder & Langford, P.C.)

RESOLUTION NO. 08-628

1 WHEREAS, the Office of Attorney General continues to require the legal services of Yoder &
2 Langford, P.C., to represent the Tohono O'odham Nation in matters involving Internal
3 Revenue Service audits and investigations of the Districts and the Nation, and matters
4 related to retirement and pension plans; and

5 WHEREAS, the Attorney General has recommended a budget of \$45,000 for fiscal year 2009, for the
6 period from October 1, 2008 to September 30, 2009; and

7 WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of
8 Attorney General, account number 01-1031-810; and

9 WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney
10 contract and recommend approval by the Legislative Council.

11 NOW, THEREFORE, BE IT RESOLVED THAT:

- 12 1. The Tohono O'odham Legislative Council approves the Attorney Contract with
13 the law firm of Yoder & Langford in the amount of \$45,000.00 for FY2009, for the
14 period from October 1, 2008 to September 30, 2009, substantially in the form
15 attached hereto.
- 16 2. Funding for the Attorney Contract shall be provided from the budget of the Office
17 of Attorney General (01-1031-810).
- 18 3. The Chairperson of the Nation is authorized and directed to execute the Attorney
19 Contract.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day
21 of OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
22 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section
23 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
24 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat. 984).




