2	Stockton LLP in litigating the Nation's claims against the United States for trust assets
3	mismanagement; and
4	WHEREAS, the Attorney General has recommended a budget of \$200,000 for this purpose in fiscal
5	year 2009, for the period from October 1, 2008 to September 30, 2009; and
6	WHEREAS, the attorney contract will be funded from the budget of the Office of Attorney General,
7	account number 01-1031-810; and
8	WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the attorney
9	contract and recommend approval by the Legislative Council.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
11	(1) Approves the attorney contract with the Kilpatrick Stockton LLP law firm in the
12	amount of \$200,000.00 for Fiscal Year 2009, for the period from October 1, 2008
13	to September 30, 2009, substantially in the form attached hereto;
14	(2) The attorney contract will be funded from the operating budget of the Office of
15	Attorney General, account number 01-1031-810; and
16	(3) Authorizes the Chairperson of the Nation to execute the contract and the
17	attached Fee Agreement.
