

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Attorney Contract for FY2009 with the Law Firm of Kilpatrick Stockton LLP)**

**RESOLUTION NO. 08-629**

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Kilpatrick**  
2 **Stockton LLP in litigating the Nation's claims against the United States for trust assets**  
3 **mismanagement; and**

4 **WHEREAS, the Attorney General has recommended a budget of \$200,000 for this purpose in fiscal**  
5 **year 2009, for the period from October 1, 2008 to September 30, 2009; and**

6 **WHEREAS, the attorney contract will be funded from the budget of the Office of Attorney General,**  
7 **account number 01-1031-810; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the attorney**  
9 **contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 11 (1) **Approves the attorney contract with the Kilpatrick Stockton LLP law firm in the**  
12 **amount of \$200,000.00 for Fiscal Year 2009, for the period from October 1, 2008**  
13 **to September 30, 2009, substantially in the form attached hereto;**  
14 (2) **The attorney contract will be funded from the operating budget of the Office of**  
15 **Attorney General, account number 01-1031-810; and**  
16 (3) **Authorizes the Chairperson of the Nation to execute the contract and the**  
17 **attached Fee Agreement.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day**  
19 **of OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section**  
21 **2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**


