1 **WHEREAS, by Resolution Number 07-478 the Tohono O'odham Legislative Council approved the**
2 **Low Income Home Energy Assistance Program budget in the amount of \$53,980.00; and**

3 **WHEREAS, the Tohono O'odham Nation's award for FY2009 funding through the State of Arizona,**
4 **Department of Economic Security, Community Services Administration was decreased**
5 **from \$53,980.00 to \$38,390.00 for contract period July 01, 2008 through June 30, 2009;**
6 **and**

7 **WHEREAS, the Tohono O'odham Department of Human Services, Family Assistance Division, Low**
8 **Income Home Energy Assistance Program (LIHEAP) has submitted the attached budget**
9 **amendment #1 which decreases Line Item 858 LIHEAP Payments from \$49,795.59 to**
10 **\$34,206.00, and Line Item 900 Indirect Cost from \$678.41 to \$678.00 for a total budget**
11 **of \$38,390.00; and**

12 **WHEREAS, the Executive Branch developed and obtained committee approval of the Family**
13 **Assistance Division, Low Income Home Energy Assistance Program budget**
14 **amendment #1 to decrease Line Item 858 LIHEAP Payments from \$49,795.59 to**
15 **\$34,206.00 and Line Item 900 Indirect Cost from \$678.41 to \$678.00 for a total budget**
16 **of \$38,390.00, which is attached and incorporated by this reference, to be effective July**
17 **01, 2008 through June 30, 2009, and requests authorization to expend funds.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
19 **authorizes the budget amendment #1 which reflects a decrease in line item 858**
20 **LIHEAP Payments from \$49,795.59 to \$34,206.00, and Line Item 900 Indirect Cost from**
21 **\$678.41 to \$678.00 for a total budget of \$38,390.00 and authorizes the Executive Branch**
22 **to expend funds in the attached Family Assistance Low Income Home Energy**
23 **Assistance Budget Amendment #1 effective July 01, 2008 through June 30, 2009. The**
24 **budget amendment reflects the decrease from \$53,980.00 to \$38,390.00 which is a**
25 **decrease of \$15,590.00.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
27 **Chairman, Vice-Chairman, and any designated official to expend and administer the**
28 **budget amendment #1 as attached, provided that any amendments affecting the funds**
29 **or funding level shall be submitted for further prior approval by the Tohono O'odham**
30 **Legislative Council.**






