3		amount of \$1,929,827.02; and
4	WHEREAS,	the TohonoO'odhamNationreceivedacarry overgrantSpecialDiabetesProgramsfor all the Control of the Co
5		Indians for FY 2009 and awarded the grant to the Healthy O'odham Promotion
6		Program under the Health & Human Services; and
7	WHEREAS,	by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the
8		establishment of the Community Based Diabetes Prevention Program, funded by the
9		SpecialDiabetesProgramsforIndians, authorizedbytheBalancedBudgetActof1997;

11	WHEREAS,	the Tohono O'odham Department of Health and Human Services Division of Health
12		O'odham Promotion Program is seeking approval to increase the FY09 base budget in
13		the amount \$1,929,827.02, through carryover funds in the amount of \$3,184,789.72.
14		The carryover funding amount of \$3,184,789.72 and the base budget amount of
15		\$1,929,827.02 equals to a new total amount of \$5,114,616.74, and will be retroactive for
16		FY 2009; and
17	WHEREAS,	the Indirect Cost Rate (IDC) to the budget has increased from \$293,695.89 by
18		\$362,905.17 totaling a new IDC amount of \$656,601.06.
19	NOW, THE	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
20		1. Approves and authorizes expenditures for the Division of Health Promotion
21		Program Fiscal Year 2009 carryover amount of \$3,184,789.72 into the division's
22		FY09 budget of \$1,929,827.02 to increase the total budget amount to
23		\$5,114,616.74 and will be retroactive for FY09.
24		2. Approves an increase of the Indirect Cost Rate from \$293,695.89 to \$362,905.17
25		for a new total IDC rate of \$656,601.06.
26		3. Authorizes the Chairman, Vice Chairman, and any designated official to expend
27		and administer the budget as attached, provided that any amendments affecting
28		the funds or funding level shall be submitted for further final approval by the
29		Tohono O'odham Legislative Council.
30		4. Authorizes the Chairman, Vice-Chairman and any designated official to expend
31		and administer the FY09 budget to reflect the appropriate dates as 10/01/08 -
32		09/30/09.
