

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2009 Legislative Branch Surplus Budget in
the amount of \$496,044.02)**

RESOLUTION NO. 08-635

1 **WHEREAS, the Legislative Council is authorized “to manage any funds within the exclusive**
2 **control of the Tohono O’odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members” provided that “[a]ll expenditures of these funds**
4 **shall be pursuant to appropriations or budgets” authorized by resolution or ordinance**
5 **(Constitution of the Tohono O’odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, surplus funds have been identified and reported to the Budget and Finance**
7 **Committee from revenues exceeding the FY 2008 general revenue projection (“FY 2008**
8 **Surplus Funds”); and**

9 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY 2009**
10 **surplus budget to address long-standing needs of the Branch; and**

11 **WHEREAS, the attached surplus budget in the total amount of \$496,044.02 of which \$188,000.00**
12 **of the total is a one-time appropriation for Supplies-Other, Alternations &**
13 **Renovations, Major Capital Equipment, and Public Relations and an additional**
14 **amount of \$308,044.02 which is reoccurring funding for Personnel,**
15 **Training/Registration and Travel/Transportation; and**

16 **WHEREAS, the amount of \$308,044.02 will be integrated into the FY 2009 Legislative Branch base**
17 **budget; and**

18 **WHEREAS, the FY 2009 Legislative Branch Surplus Budget has been reviewed by the Budget and**
19 **Finance Committee.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby approves**
21 **the attached FY 2009 Legislative Branch Surplus Budget in the amount of \$496,044.02**
22 **to be appropriated from FY 2008 Surplus Funds, and effective retroactive to October**
23 **1, 2008.**

24 **BE IT FURTHER RESOLVED that in accordance with the FY 2009 Legislative Branch**
25 **surplus budget attached hereto the amount of \$308,044.02 shall be integrated into the**
26 **base budget and shall be recurring for future fiscal years.**

27 **BE IT FURTHER RESOLVED that in accordance with the FY 2009 Legislative Branch**
28 **surplus budget attached hereto the amount of \$188,000.00 shall be a one-time**
29 **appropriation to be expended within the FY 2009 fiscal year.**

30 **BE IT FINALLY RESOLVED by the Tohono O’odham Legislative Council that the Tohono**
