

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting December 16, 2008 Special Session to Address the Legislative Rules and Other**  
**Matters the Council Votes to Add to the Agenda)**

**LEGISLATIVE ORDER NO. 08-638**

1 **WHEREAS, the Legislative Council is vested with the power “to establish rules and procedures**  
2 **to regulate all meetings of the Tohono O’odham Council, standing committees,**  
3 **boards and special committees.” (Constitution of the Tohono O’odham Nation,**  
4 **Article VI, Section 1 (a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O’odham Legislative Council vest the Council**  
6 **with the authority to “by majority vote, call for a special session” (Legislative Rules**  
7 **of the Tohono O’odham Legislative Council, Article I, Section 1.D.2.); and**

8 **WHEREAS, the Legislative Council Rules Committee has requested a special session to address**  
9 **the Legislative Rules and other matters the Council votes to add to the agenda.**

10 **NOW, THEREFORE, BE IT ORDERED that the Tohono O’odham Legislative Council hereby sets a**  
11 **special session on December 16, 2008 to address the Legislative Rules and other**  
12 **matters the Council votes to add to the agenda.**

13 **BE IT FINALLY ORDERED by the Tohono O’odham Legislative Council that attendance at the**  
14 **December 16, 2008 special session shall be mandatory for all Legislative Council**  
15 **representatives.**

16 **The foregoing Order was passed by the Tohono O’odham Legislative Council on the 14<sup>TH</sup>. Day of**  
17 **OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
19 **Article VI, Section 1 (a) of the Constitution of the Tohono O’Odham Nation, adopted by the Tohono**  
20 **O’Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
22 **Stat. 984).**
