7		an Initiative Funding and Implementation Plan (the FIP) which authorized the

25		a Revenue Allocation Plan and caused the Plan to be submitted for approval by the
26		Phoenix Area Office of the Bureau of Indian Affairs in accordance with authority
27	į	delegated to the Area Office by the Secretary of the Interior; and
28	WHEREAS,	by letter dated December 18, 1997 the Area Office approved the Revenue Allocation
29		Plan with respect to the Initial Per Capita Distribution and disapproved the Plan with

RESOLUTION NO. 08-647 (Accepting Certification of Eligible Members and Authorizing the Initial Expenditure of Funds for Per Capita Payments under the Initiative) Page 2 of 4 WHEREAS, pursuant to Resolution No. 2000-472 the FIP was amended by Amendment No. 1 and 1 2 further amended by Amendment 2; and Amendment No. 2 requires an Agreement 3 with a reputable financial institution for the establishment of restricted accounts for 4 Minor Eligible Members; and 5 WHEREAS, an Agreement has been negotiated with Wells Fargo for the establishment of restricted accounts for Minor Eligible Members; and 6 7 WHEREAS, the Tohono O'odham Legislative Council has accepted and approved Certifications 8 of Eligible Members for the Initial Per Capita Distribution, and disbursements have 9 been made to such Members; and 10 WHEREAS, the Enrollment Office has filed with the Tohono O'odham Legislative Council a 11 Certification of Eligible Members listing 37 adult members who are eligible for 12 receipt of the Initial Per Capita Distribution; and 13 WHEREAS, all conditions under the applicable laws of the United States and the Nation have 14 been satisfied to permit the disbursement of the Initial Per Capita Distribution to the 15 Members listed in the Certification of Eligible Members. NOW, THEREFORE, BE IT RESOLVED THAT: 16 17 1. The Tohono O'odham Legislative Council hereby accepts and approves the 18 Certification of Eligible Members, in the form attached hereto. 19 2. The Tohono O'odham Legislative Council authorizes (a) the transfer of the sum of 20 \$74,000.00 from the Per Capita Account to the special checking account 21 established at Bank of America (the Per Capita Checking Account); and (b) upon 22 the authorized signature of the Nation, issuance of a check on the Per Capita Checking Account in the amount of (I) \$2,000.00 to each Eligible Member residing 23 in the United States and listed in the attached Certification of Eligible Members, 24 25 and (ii) \$1,400.00 to each Eligible Member residing outside the United States and listed in the attached Certification, with the balance of \$600.00 withheld and 26 27 remitted to the Internal Revenue Service pursuant to the requirements of federal 28 law. 29 3. The Chairman of the Nation is authorized to execute such other documents as

may be necessary to implement this Resolution.
