

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the FY 2009 Department of Health and Human Services, Family Assistance Division - Budget Amendment #1 - Account No. 01-1300)**

**RESOLUTION NO. 08-651**

1 **WHEREAS, in FY2005 the Tohono O'odham Nation, Executive Office transferred from their budget,**  
2 **\$55,000.00 to provide burial assistance services to members who are not eligible for**  
3 **these services through the BIA P.L. 93-638 Social Service Contract; and**

4 **WHEREAS, in FY08 the Tohono O'odham Legislative Council approved budget amendment #1 for**  
5 **the Family Assistance Division Tribal budget in the amount of \$100,000.00 to provide**  
6 **burial assistance services to eligible members who did not meet the eligibility criteria**  
7 **for burial assistance services under the BIA WAG funds; and**

8 **WHEREAS, the Department of Health and Human Services has recognized the increased need in**  
9 **the costs of burial assistance services and the number of individuals requiring these**  
10 **services; and**

11 **WHEREAS, the following table indicates the number of tribal burial assistance services that were**  
12 **provided for, FY2006, FY2007 and FY2008 (October 2007 through August 2008); and**

15 **WHEREAS, the projection for FY09 for tribal burial assistance services is based on actual FY08**  
16 **statistics; and**

17 **WHEREAS, the Executive Branch developed and obtained committee approval of the Family**  
18 **Assistance Division, FY09 Tribal budget amendment #1 to increase the Wake**  
19 **Assistance line item by \$100,000.00 for a total of \$155,000.00 which is attached and**  
20 **incorporated by this reference, to be effective October 1, 2008 through September 30,**  
21 **2009, and requests authorization to expend funds. The fund source is the FY08 tribal**  
22 **surplus funds.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby:**

- 24 **1. Approve budget amendment No. 1 and appropriates \$100,000.00 from the FY08**  
25 **tribal surplus funds.**
- 26 **2. Approve expenditure of funds as per attached budget.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairperson and**  
28 **any designated official are hereby authorized to negotiate, execute and expend funds,**  
29 **provided however, that any amendments affecting the funds or funding levels shall be**  
30 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
