

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Legislative Order No. 08-637 "Setting November 25, 2008 Special Session to Hear
a Presentation from the Enrollment Committee about the Enrollment Ordinance and
Process and Other Matters the Council Votes to Add to the Agenda" to Reschedule
November 25, 2008's Special Session for January 13, 2009)**

LEGISLATIVE ORDER NO. 08-657

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures**
2 **to regulate all meetings of the Tohono O'odham Council, standing committees,**
3 **boards and special committees." (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1 (a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**
6 **with the authority to "by majority vote, call for a special session" (Legislative Rules**
7 **of the Tohono O'odham Legislative Council, Article I, Section 1.D.2.); and**

8 **WHEREAS, by Legislative Order No. 08-637, the Legislative Council set a special session date of**
9 **November 25, 2008 for an Enrollment Committee presentation on the Enrollment**
10 **Ordinance and process; and**

11 **WHEREAS, the Legislative Rules Committee requests that the special session be rescheduled to**
12 **January 13, 2009.**

13 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby amends**
14 **Legislative Order No. 08-637 to reschedule the November 25, 2008 special session for**
15 **January 13, 2009.**

16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 04TH. Day of**
17 **NOVEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by**
19 **Article VI, Section 1 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
20 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**
