

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Amendment #1 to Carryover to \$130,348.00 FY2009 24-1807
Initiative Accounting Budget)

RESOLUTION NO. 08-677

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2009 Initiative Admin**
2 **Accounting G/L Budget pursuant to Tohono O'odham Legislative Council Resolution**
3 **No. 08-272; and**

4 **WHEREAS, line item 830 AUDIT is added to the FY09 Initiative Admin Accounting G/L Budget and**
5 **reflects a carryover amount of \$130,348.00 for costs associated with the minor**
6 **account audit for a total budget amount of \$185,226.83; and**

7 **WHEREAS, carryover funds from the FY2008 budget to the FY2009 have been authorized by the**
8 **Tohono O'odham Legislative Council per Resolution #06-545; and**

9 **WHEREAS, the FY09 24-1807 Initiative Accounting Budget Amendment #1 has been reviewed by**
10 **the Budget and Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 12 **1. Approves the addition of line item 830 AUDIT to the FY09 24-1807 Initiative**
13 **Accounting Budget for costs associated with the minor account audit.**
- 14 **2. The Tohono O'odham Legislative Council re-authorizes to carryover from FY2008**
15 **Initiative Accounting Budget the amount of \$130,348.00 to the FY2009 Initiative**
16 **Accounting Budget to continue and complete the minor account audit pursuant**
17 **to Tohono O'odham Legislative Council Resolution #06-545.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation's Officials, to wit: the Chairman, Vice-Chairman and any designated official**
20 **are hereby authorized to administer the budget, provided however, that any**
21 **amendments affecting the funds or funding levels of the budget shall be submitted**
22 **for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 17TH Day**
24 **of NOVEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
27 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
