(Approving a \$500.00 Holiday Gift for the Employees of the Executive Branch, Judicial Branch and the Legislative Branch including all Appointed and Elected Officials of the three Branches)

RESOLUTION NO. 08-678

1 **WHEREAS, the Tohono O'odham Nation Chairman and Vice Chairman have prepared a proposal**
2 **for a Holiday Gift of \$500.00 to each employee of the Executive Branch, Judicial**
3 **Branch and the Legislative Branch including all Appointed and Elected Officials of**
4 **the three Branches; and**

5 **WHEREAS, the purpose of this legislative action a Holiday Gift is defined as a sum of money**
6 **granted to an employee in addition to a regular pay; and**

7 **WHEREAS, in accordance with the Nations Personnel Policy Manual an employee is defined as**
8 **someone who works for another in return for a wage or salary (PPM Sec.1.B); and**

9 **WHEREAS, the Office of the Chairman and Vice Chairman have presented this proposal to the**
10 **Legislative Council Budget & Finance Committee for their consideration.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby approves a \$500.00**
12 **Holiday Gift for the Employees of the Executive Branch, Judicial Branch and the**
13 **Legislative Branch including all Appointed and Elected Officials of the three**
14 **Branches.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council, in consultation with the**
16 **Office of the Chairman & Vice Chairman, that this payment be issued on the payroll**
17 **date of December 12, 2008 for all employees and shall only be issued to those**
18 **individuals who are officially employed by the Nation on December 12, 2008.**

19 **BE IT FURTHER RESOLVED that the \$500.00 Holiday Gift is appropriated from the Fiscal Year 2008**
20 **General Fund Surplus for a total amount of \$997,376.64 in accordance with the**
21 **following schedule:**
