

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District Re-Roof Project and Appropriating \$561,770.00)**

RESOLUTION NO. 08-679

1 WHEREAS, the Tohono O'odham Nation Constitution requires that all expenditures of funds are
2 approved by the Legislative Council; and
3 WHEREAS, the San Lucy District Council by Resolutions No. SL 10-111-08 and SL 11-117-08
4 approved a Re-Roof project for the community and identified funds to support the
5 project; and
6 WHEREAS, San Lucy District since the onset of P.L. 99-503 has been addressing the housing
7 issues in the community; and
8 WHEREAS, these housing issues for San Lucy have translated into projects and are carried out
9 by its economic development arm Vi-ikam Doag Industries; and
10 WHEREAS, the Tohono O'odham Legislative Council is cognizant of the dilapidated condition
11 of houses within the nation and is strongly supportive of efforts to eradicate these
12 conditions in order to afford members to reside in a safe home that is devoid of
13 problems; and
14 WHEREAS, the Budget & Finance Committee have reviewed the proposal from San Lucy District
15 and is forwarding it to the Legislative Council for their consideration.
16 NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative hereby approved the San
17 Lucy District Re-Roof Project in the amount of \$561,770.00.
18 BE IT FINALLY RESOLVED funds from un-obligated 2009 Gaming Revenue funds of \$4,334.22; 2008
19 Budget Gaming Revenue and Mining Royalty savings of \$426,100.99; interest from
20 Gaming Revenue Account of \$131,334.79 totally \$561,770.00 shall be the source to
21 fund the San Lucy District Re-Roof Project.

22 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 17TH Day
23 of NOVEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,089.8 FOR; 444.7
24 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
25 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
26 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
27 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
28 18, 1934 (48 Stat. 984).
