

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Department of Health and Human Services, Division of Family Assistance – FY09 Tribal Low Income Home Energy Assistance Program (LIHEAP) Budget, Account No.)**

RESOLUTION NO. 08-710

1 **WHEREAS, by Resolution Number 07-478 the Tohono O'odham Legislative Council approved the**
2 **Low Income Home Energy Assistance Program budget in the amount of \$53,980.00;**
3 **and**

4 **WHEREAS, the Tohono O'odham Nation's award for FY2009 funding through the State of Arizona,**
5 **Department of Economic Security, Community Services Administration was**
6 **decreased from \$53,980.00 to \$38,390.00 for contract period July 01, 2008 through**
7 **June 30, 2009; and**

8 **WHEREAS, by Resolution Number 08-630 the State LIHEAP funding amount was reduced to**
9 **\$38,390.00; and**

10 **WHEREAS, the Department of Health and Human Services has recognized the increased need in**
11 **the costs of energy assistance services and the number of individuals and families**
12 **requiring assistance for these services; and**

13 **WHEREAS, the following table indicates the number of energy assistance services that were**
14 **provided for FY2007, FY2008 and FY2009 (July 01, 2008 through October 2008); and**

Fiscal Year	2007	2008	2009

18 **WHEREAS, the FY09 projection for utility assistance services is based on actual statistics from**
19 **July 01, 2008 through September 30, 2008; and the remaining months (October 2008**
20 **through June 30, 2009) at an average of 32 energy assistance applications per month,**
21 **(see attachment); and**

22 **WHEREAS, the Executive Branch developed and obtained committee approval of the Family**
23 **Assistance Division, Low Income Home Energy Assistance FY09 Tribal budget with the**
24 **LIHEAP payment line item 858 for \$100,800.00 which is attached and incorporated by**
25 **this reference, to be effective October 1, 2008 through June 30, 2009, and requests**
26 **authorization to expend funds. The fund source is the FY08 tribal surplus funds.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
28 **does hereby:**

- 29 **1. Approve budget amendment No. 1 and appropriates \$100,800.00 from the FY08**

Day of DECEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,362.5 FOR; -0- AGAINST; -0- NOT VOTING; and 172.0[08] ABSENT, pursuant to the powers vested in the Council by Section 1 (j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
