

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Shawn Ramon to the TERO Commission for a Term Expiring June 30, 2011)

RESOLUTION NO. 08-715

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agents" (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1(b)); and**

5 **WHEREAS, in 1985, the Papago Council enacted the Papago Employment Rights Ordinance ("TERO**
6 **Ordinance"), thereby establishing the Papago Employment Rights Commission (a.k.a.,**
7 **"TERO Commission") and vesting the Council with the power to select and appoint**
8 **TERO commissioners (TERO Ordinance, Ordinance No. 01-85, Section 6(B)(2)); and**

9 **WHEREAS, Section 6(C) of the TERO Ordinance further provides that "[c]ommissioners shall be**
10 **appointed for terms of three years, or until their successors are appointed and**
11 **qualified, provided, however, that appointments to the Commission shall be made in**
12 **such a way and for such terms that their terms shall be staggered so that the terms of**
13 **office of only two Commissioners will end in any single year"; and**

14 **WHEREAS, Evan Thomas was appointed to the TERO Commission with a term ending June 30, 2008**
15 **(Resolution No. 06-037); and**

16 **WHEREAS, the Domestic Affairs Committee has been delegated authority to "review and**
17 **recommend action by the Legislative Council on appointments of . . . TERO**
18 **Commissioners" (Plan of Operation for the Domestic Affairs Committee, Article III.D.**
19 **as adopted by Legislative Order No. 01-431); and**

20 **WHEREAS, the Domestic Affairs Committee has interviewed qualified TERO Commission**
21 **applicants, one of whom, when appointed, will serve a term commencing on the**
22 **effective date of this resolution and ending June 30, 2011 or until his successor is**
23 **appointed and qualified.**


24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appoints**
25 **Shawn Ramon to the TERO Commission commencing upon the effective date of this**
26 **resolution and ending June 30, 2011 or until his successor is appointed and qualified.**

27 **The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 15TH**
28 **day of DECEMBER, 2008 at a meeting at which a quorum was present, and by a vote of 2,534.5 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT , pursuant to the powers vested in the Council by**
30 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**




