

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating a one time funding amount of \$15,000.00 from the
FY 2008 Surplus Request for Miss Indian Arizona)

RESOLUTION NO. 08-726

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to adopt, approve**
2 **and amend annual budgets and to authorize the expenditure of funds in accordance**
3 **with these budgets. (Article VI, Section 1 (d) 3, Constitution of the Tohono O'odham**
4 **Nation); and**

5 **WHEREAS, the Tohono O'odham Nation has supported the Miss Tohono O'odham Nation**
6 **titleholder to participate in the Miss Indian Arizona Pageant; and**

7 **WHEREAS, Earlene Patricio was the title holder of the Miss Tohono O'odham Nation and**
8 **participated and successfully earned the title of Miss Indian Arizona 2008-2009; and**

9 **WHEREAS, the Miss Indian Arizona Committee notified Earlene Patricio that the Miss Indian**
10 **Arizona Committee does not fully fund the title holder and that funding would be**
11 **requested from the representing tribe of the titleholder; and**

12 **WHEREAS, the Miss Indian Arizona Committee provided a budget and requested by letter that**
13 **the Tohono O'odham Nation financially support Miss Indian Arizona; and**

14 **WHEREAS, the Chairman and Vice Chairman of the Tohono O'odham Nation have determined**
15 **it necessary to provide funding for Miss Indian Arizona to ensure that she has the**
16 **necessary accommodations to represent the Tohono O'odham Nation and the tribes**
17 **of Arizona; and**

18 **WHEREAS, the proposed budget was presented to the Human Resources Development and**
19 **Budget and Finance Committees of the Legislative Council.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
21 **approve the Miss Indian Arizona Budget in its form attached hereto and appropriates**
22 **a one time funding amount of \$15,000.00 from existing FY 2008 Surplus funding to**
23 **fund this Budget.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation, Chairman, Vice-Chairman and any designated officials are authorized to**
26 **administer the attached budget, provided, however that any amendments affecting**
27 **these funds or funding levels that are budgeted shall be submitted for prior approval**
28 **by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day**
30 **of DECEMBER, 2008 at a meeting at which a quorum was present with a vote of 1,380.6 FOR;**
31 **1,055.65 AGAINST; 98.25 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**
32 **Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
33 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat. 984).**
