

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Ge Oidag (Big Field) Community Carry Forward of 1<sup>st</sup> Supplement  
from Fiscal Year 2000 to Fiscal Year 2009)**

**RESOLUTION NO. 09-038**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 99-550 approved a \$500,000.00**  
2 **Supplemental Budget for the Sells District in Fiscal Year 2000; and**

3 **WHEREAS, the Sells District portioned out the supplement fund in the amount of \$58,000 to each**  
4 **of the four communities that make up the Sells District; and**

5 **WHEREAS, the Ge Oidag (Big Field) Community currently has a balance available of \$21,544.80 of**  
6 **the Supplemental Budget from Fiscal Year 2000 to be carried forward into Fiscal Year**  
7 **2009; and**


8 **WHEREAS, the attached budget and justification has been prepared and approved by Ge Oidag**  
9 **(Big Field) Community Resolution No. BF-35-08; and by Sells District Council**  
10 **Resolution No. SD-105-08.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
12 **carry forward of \$21,544.80 from the balance of the Supplemental Budget for Ge Oidag**  
13 **(Big Field) Community from Fiscal Year 2000 to Fiscal Year 2009.**

14 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **Chairperson and any designated official to expend and administer the budget, as**  
16 **attached, provided that any modifications/amendments affecting the funds or funding**  
17 **levels of the budget shall be submitted for further prior approval by the Tohono**  
18 **O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day**  
20 **of JANUARY, 2009 at a meeting at which a quorum was present with a vote of 2,306.6 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and 227.9 [08] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
