

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the extension of the carryover for the Enhancement Grant (NG-03-06-0270-06)**  
**for the Venito Garcia Library and Archives from the Institute of Museum and Library**  
**Services, Native American Library Services (IMLS-NALS))**

RESOLUTION NO. 09-057

1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito**  
2 **Garcia Library and Archives, the library agency for the Tohono O'odham Nation and**  
3 **FOTOL approved the FY 2007 Venito Garcia Library & Archives Bookmobile; and**

4 **WHEREAS, the Venito Garcia Library and Archives is charged with library development for the**  
5 **Tohono O'odham Nation; and**

6 **WHEREAS, the Institute of Museum and Library Services Enhancement grant has been received**  
7 **to expand library services with a bookmobile project as per attached letter from the**  
8 **IMLS-NALS.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
10 **approves the extension of the carryover the Basic Grant from IMLS-NALS for**  
11 **Bookmobile Project Enhancement (grant number NG-03-06-0270-06) for the period**  
12 **from October 1, 2008 until September 30, 2009 and authorize use of these fund in the**  
13 **amount of \$88,212.02 for FY 2009 as detailed in the attached budget for the purpose**  
14 **of purchasing and operating a bookmobile.**

15 **BE IT FINALLY RESOLVED that the Tohono Nation Officials, to wit: the Chairman and any**  
16 **Designated Official are hereby authorized to negotiate and expend the grant,**  
17 **provided, however, that any amendments affecting the funds or funding levels of the**  
18 **grant shall be submitted for further approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>. Day**  
20 **of JANUARY, 2009 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and 199.2[07]ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
