

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To Amend Enrollment Resolution No. 09-066)

RESOLUTION NO. 09-170

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" (Constitution of the Tohono O'odham**
4 **Nation Article VI Section 1(b); and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides**
6 **that the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on February 09, 2009 the Legislative Council pursuant to Resolution No. 09-066,**
9 **approved Octaviana M. Guerra-TwoTwo Roll No. 4354-B-08 for membership in the**
10 **Tohono O'odham Nation; and**

11 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
12 **and family tree Octaviana M. Guerra-TwoTwo listed with Roll No. 4354-B-08 was**
13 **given the same number assigned to another member; (Daniel Sanriquez, Jr.**
14 **pursuant to Resolution No. 09-008); and**

15 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a**
16 **number has been assigned to an application it shall not be changed; and**

17 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
18 **Legislative Council shall cause the membership roll be kept current.**

19 **NOW, THEREFORE, BE IT RESOLVED THAT:**

20 **1. The Tohono O'odham Legislative Council approves a modification of**
21 **Resolution No. 09-066 as follows:**

22 **The Roll No. listed for Daniel Sanriquez Jr. shall retain the Roll#. 4354-B-08 the**
23 **Roll No. Listed for Octaviana M. Guerra-TwoTwo be changed to 4368-B-08 to**
24 **reflect the number originally assigned to the application of Octaviana M.**
25 **Guerra-TwoTwo February 09, 2009 which was approved by this Council**
26 **pursuant to Resolution No. 09-066.**

27 **2. The Enrollment Committee shall make the necessary changes in the records**
28 **of the Enrollment Office to incorporate the stated modification.**

29 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH Day**
30 **of APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,443.3 FOR; -0 AGAINST;**
31 **91.20 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 of**
32 **Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation,**
33 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
34 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
35 **Act of June 18, 1934 (48 Stat. 984).**
