

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Gabriel F. Encinas to the Enrollment Committee)**

RESOLUTION NO. 09-175

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agenda" (Article VI, Section 1(b) of the Constitution**
4 **of the Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended Ordinance No. 05-81,**
6 **the "Enrollment Ordinance" as amended which establishes an Enrollment Committee**
7 **to oversee enrollment into memberships in the Tohono O'odham Nation; and**

8 **WHEREAS, the Enrollment Ordinance provides that the Enrollment Committee "shall be**
9 **composed of five members of the Tohono O'odham Nation who are bilingual in the**
10 **O'odham and English languages" and whose members "shall be appointed by the**
11 **Chairman of the Nation, subject to the approval by the Tohono O'odham Legislative**
12 **Council" (Enrollment Ordinance, Article II, Section 1.A. and 1.B.); and**

13 **WHEREAS, Committee members "shall be appointed for terms of three years or until their**
14 **successors are appointed. The appointments of the five members shall be staggered**
15 **so that no more than two members shall be appointed or reappointed each year."**
16 **(Enrollment Ordinance, Article II, Section 1.C.); and**

17 **WHEREAS, Gabriel F. Encinas was appointed by Resolution No. 07-124 to a three year term ending**
18 **January 1, 2009 and remains on the committee until he is replaced by a successor; and**

19 **WHEREAS, if approved, Gabriel F. Encinas would serve on the Enrollment Committee for a three**
20 **year term commencing on the effective date of this resolution and ending January 1,**
21 **2012 provided that he would continue to serve until replaced by a successor who is**
22 **appointed in accordance with the Enrollment Ordinance; and**

23 **WHEREAS, the Rules Committee of the Legislative Council have reviewed the Chairman's**
24 **appointment.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
26 **and approves the appointment of Gabriel F. Encinas to the Enrollment Committee for**
27 **a three year term commencing on the effective date of this resolution and ending**
28 **January 1, 2012 provided that he shall continue to serve until replaced by a successor**
29 **who has been appointed in accordance with the Enrollment Ordinance.**
