

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointment of Delores I. Stevens to the Enrollment Committee)**

**RESOLUTION NO. 09-176**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**  
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**  
3 **committees, boards, officers and agenda" (Article VI, Section 1(b) of the Constitution**  
4 **of the Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended Ordinance No. 05-81,**  
6 **the "Enrollment Ordinance" as amended which establishes an Enrollment Committee**  
7 **to oversee enrollment into memberships in the Tohono O'odham Nation; and**

8 **WHEREAS, the Enrollment Ordinance provides that the Enrollment Committee "shall be**  
9 **composed of five members of the Tohono O'odham Nation who are bilingual in the**  
10 **O'odham and English languages" and whose members "shall be appointed by the**  
11 **Chairman of the Nation, subject to the approval by the Tohono O'odham Legislative**  
12 **Council" (Enrollment Ordinance, Article II, Section 1.A. and 1.B.); and**

13 **WHEREAS, Committee members "shall be appointed for terms of three years or until their**  
14 **successors are appointed. The appointments of the five members shall be staggered**  
15 **so that no more than two members shall be appointed or reappointed each year."**  
16 **(Enrollment Ordinance, Article II, Section 1.C.); and**

17 **WHEREAS, if approved, Delores I. Stevens would serve on the Enrollment Committee for a three**  
18 **year term commencing on the effective date of this resolution and ending January 1,**  
19 **2012 provided that she would continue to serve until replaced by a successor who is**  
20 **appointed in accordance with the Enrollment Ordinance; and**

21 **WHEREAS, the Rules Committee of the Legislative Council have reviewed the Chairman's**  
22 **appointment.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
24 **and approves the appointment of Delores I. Stevens to the Enrollment Committee for**  
25 **a three year term commencing on the effective date of this resolution and ending**  
26 **January 1, 2012 provided that he shall continue to serve until replaced by a successor**  
27 **who has been appointed in accordance with the Enrollment Ordinance.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day**  
29 **of APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,443.95 FOR; -0-**  
30 **AGAINST; 90.55 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
31 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
32 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat. 984).**
