

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Legislative Rules of the Tohono O'odham Legislative Council)

LEGISLATIVE ORDER NO. 09-188

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**
2 **Legislative Council with the power to establish rules and procedures to regulate all**
3 **meetings of the Council and its standing committees (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a) and (b)); and**

5 **WHEREAS, the Legislative Council has exercised this power by adopting and amending the**
6 **Legislative Rules of the Tohono O'odham Legislative Council ("Legislative Rules") in**
7 **Legislative Order No. 06-460, re-adopting Legislative Rules and Legislative Order No.**
8 **06-635, "September 2006 Legislative Rules Amendments"; and**

9 **WHEREAS, the Legislative Rules Committee has completed a review of succeeding Legislative**
10 **Rules and has drafted amendments, ("April 2009 Legislative Rules Amendments"),**
11 **which are incorporated by this reference and are dated April 2009; and**

12 **WHEREAS, all Legislative Council representatives were given the opportunity to respond to**
13 **proposed Rules amendments during a comment period ending September 30, 2008,**
14 **and a presentation of the amendments was made to the Legislative Council during**
15 **the December 2008 general session; and**

16 **WHEREAS, all Legislative Council representatives were given an additional opportunity to**
17 **respond to proposed Rules amendments during a second comment period ending**
18 **April 3, 2009; and**

19 **WHEREAS, the Rules Committee has reviewed all comments and recommends adoption of the**
20 **Legislative Rules amendments.**

21 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby adopts**
22 **the April 2009 Legislative Rules Amendments, which shall be effective immediately**
23 **upon the adjournment of the April 2009 Legislative Council general session.**

24 **BE IT FINALLY ORDERED that the Tohono O'odham Legislative Council hereby repeals the**
25 **Legislative Council Session Attendance Rules adopted by Legislative Order No. 02-**
26 **246, Legislative Order No. 06-460 (re-adopting Legislative Rules), Legislative Order**
27 **No. 06-635 (adopting September 2006 Legislative Rules Amendments), and all prior**
28 **versions of the Legislative Rules of the Tohono O'odham Legislative Council.**

29 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 14TH Day of**
30 **APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,289.35 FOR; 90.55**
31 **AGAINST; -0- NOT VOTING; and 154.6 [09] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
33 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
35 **Stat. 984).**


