

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
( Approving an Increase of \$27,156.85 to the Election Board Budget for a Total  
Budget of \$179,897.38)**

**RESOLUTION NO. 09-193**

1 **WHEREAS, in accordance to the Uniform Election Ordinance, the Election Board has full power,**  
2 **jurisdiction and authority to conduct elections of public officers of the Tohono**  
3 **O'odham; and**

4 **WHEREAS, the current Election Board base budget amount of \$152,740.53, does not include funds**  
5 **to support the cost for the Nation's 2009 Election; and**

6 **WHEREAS, the Election Board request surplus funds to compensate the District Election Boards**  
7 **for their duties to attend Election Board orientation and conduct the primary and**  
8 **general elections in their perspective district polling sites, posting of election results**  
9 **and for meeting of the Election Board; and**

10 **WHEREAS, the Election Board has devised a budget indicating in which line items additional**  
11 **monies will be needed for the FY-2009 Election.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **a one time increase of \$27,156.85 to the Election Board budget from surplus funds to**  
14 **support expenses not included in the current budget for the FY-2009 Election,**  
15 **increasing the Election Board's FY-2009 budget to a total of \$179,897.38.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Chairperson and any designated official to expend and administer the budget as**  
18 **attached, provided that any amendments affecting the funds or funding level shall be**  
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>. Day**  
21 **of APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and 199.2 [05] ABSENT, pursuant to the powers vested in the Council by Section**  
23 **1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
