

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Authorizing Fiscal Year 2009 Initiative Administrative Budget**  
**Amendment # 1 to add \$95,745.80 from the Desert Diamond savings to increase**  
**the Enrollment Payment Roll budget to a total of \$399,187.45)**

**RESOLUTION NO. 09-196**

1 **WHEREAS, Initiative IN-01-97 Account No. 24-1810 requires that the Nation provide for the**  
2 **annual administrative cost of implementing the provisions of the initiative with**  
3 **Resolution No. 05-582; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved the establishment of a reserve to**  
5 **fund the necessary administrative requirements; and**

6 **WHEREAS, the Executive Branch has prepared a Fiscal Year 2009 budget to continue its Initiative**  
7 **Administration; and**

8 **WHEREAS, the Enrollment Program will conduct a major outreach program for the Nation to**  
9 **ensure that all members eligible for the fourth per capita payout complete the Eligible**  
10 **Verification Form required by Tohono O'odham Nation; and**

11 **WHEREAS, the Enrollment Program is requesting additional funds in the amount of \$95,745.80**  
12 **to support the associated cost to process verification forms required prior to the**  
13 **Initiative Fourth Per Capita payment to the members of the Nations.**

14 **NOW, THEREFORE, IT BE RESOLVED that the Tohono O'odham Legislative Council hereby**  
15 **appropriates and approves and authorizes the Fiscal Year 2009, Initiative**  
16 **Administrative budget 24-1810 Amendment No. 1 to add \$95,745.80 from the Desert**  
17 **Diamond savings account to increase the Enrollment Payment Roll budget to a total**  
18 **amount of \$399,187.45 on a one time basis for costs associated with the projected per**  
19 **capita payment verification.**

20 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves to add new**  
21 **items 612-Occasional Appointments, and 700-Advertisement, be added to the FY09**  
22 **Initiative Administrative Enrollment Payment Roll budget for cost associated with**  
23 **future per capita verification.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
25 **Chairman and or any designated official to expend and administer the budget as**  
26 **attached, provided that any amendments affecting the funds or funding level shall be**  
27 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>. Day**  
29 **of APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0- AGAINST;**  
30 **-0- NOT VOTING; and 199.2[07]ABSENT, pursuant to the powers vested in the Council by Section 1**  
31 **(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
34 **Stat. 984).**




