

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY2009 with the Law Firm of Tiffany & Bosco P.A.)

RESOLUTION NO. 09-200

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of Tiffany &**
2 **Bosco P.A. to represent the Tohono O'odham Nation in matters relating to the West**
3 **Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended a budget of \$20,000.00 for fiscal year 2009 for**
5 **the period from March 30, 2009 to September 30, 2009; and**

6 **WHEREAS, the funding for this Attorney Contract will come from the \$220,000.00 for professional**
7 **services approved and appropriated by Resolution No. 09-160 as Amendment No. 1 to**
8 **the budget of the Office of Attorney General; and**

9 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney**
10 **contract and recommend approval by the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that:**

- 12 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with**
13 **the law firm of Tiffany & Bosco P.A. in the amount of \$20,000.00 for FY2009, for the**
14 **period from March 30, 2009 to September 30, 2009, substantially in the form**
15 **attached hereto.**
- 16 **2. Funding for the Attorney Contract will come from the \$220,000.00 for**
17 **professional services approved and appropriated by Resolution No. 09-160 as**
18 **Amendment No. 1 to the budget of the Office of Attorney General.**
- 19 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**
20 **Contract.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH. Day**
22 **of APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of**
24 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
26 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




