9	WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney
10	contract and recommend approval by the Legislative Council.
11	NOW, THEREFORE, BE IT RESOLVED that:
12	1. The Tohono O'odham Legislative Council approves the Attorney Contract with
13	the law firm of Gammage & Burnham in the amount of \$20,000.00 for FY2009, for
14	the period from March 30, 2009 to September 30, 2009, substantially in the form
15	attached hereto.
16	2. Funding for the Attorney Contract will come from the \$220,000.00 for
17	professional services approved and appropriated by Resolution No. 09-160 as
18	Amendment No. 1 to the budget of the Office of Attorney General.
19	3. The Chairperson of the Nation is authorized and directed to execute the Attorney
