

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract for FY2009 with the Law Firm of Gammage & Burnham)**

RESOLUTION NO. 09-201

1 WHEREAS, the Office of Attorney General requires the legal services of the law firm of Gammage  
2 & Burnham to represent the Tohono O'odham Nation in matters relating to the West  
3 Valley Resort project; and

4 WHEREAS, the Attorney General has recommended a budget of \$20,000.00 for fiscal year 2009 for  
5 the period from March 30, 2009 to September 30, 2009; and

6 WHEREAS, the funding for this Attorney Contract will come from the \$220,000.00 for professional  
7 services approved and appropriated by Resolution No. 09-160 as Amendment No. 1 to  
8 the budget of the Office of Attorney General; and

9 WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney  
10 contract and recommend approval by the Legislative Council.

11 NOW, THEREFORE, BE IT RESOLVED that:

- 12 1. The Tohono O'odham Legislative Council approves the Attorney Contract with  
13 the law firm of Gammage & Burnham in the amount of \$20,000.00 for FY2009, for  
14 the period from March 30, 2009 to September 30, 2009, substantially in the form  
15 attached hereto.
- 16 2. Funding for the Attorney Contract will come from the \$220,000.00 for  
17 professional services approved and appropriated by Resolution No. 09-160 as  
18 Amendment No. 1 to the budget of the Office of Attorney General.
- 19 3. The Chairperson of the Nation is authorized and directed to execute the Attorney  
20 Contract.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>. Day  
22 of APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;  
23 -0- NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of  
24 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
25 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
26 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
