14		Indian reservation fire fighting agency shall have a local Board; and
15	WHEREAS,	the appointments and elections of board members shall take place with one elective
16		and appointive board members serving a term ending two years after the effective
17		dateofparticipation.The reafter, everysecondyearandasavacancyoccurs, anoffice
18		$shall\ be\ filled\ for\ a\ term\ of\ four\ years\ in\ the\ same\ manner\ as\ previously\ provided; and$
19	WHEREAS,	the Board Appointment Guidelines approved by the Legislative Council pursuant to
20		Resolution No. 03-044 is not applicable to the Local Board pursuant to Section II (B) 3
21		of the guidelines because the Local Board is created pursuant to Arizona Revised
22		Statute and not the Constitution of the Tohono O'odham Nation; and
23	WHEREAS,	the Chairman of the Nation has determined that Mr. Henry Childs is qualified and
24		willing to serve as the Civilian Representative for the Public Safety Personnel
25		Retirement System Local Board.
26	NOW, THEI	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
27		accept and approve the appointment of Mr. Henry Childs to serve as a Civilian
28		Representative for the Public Safety Personnel Retirement System Local Board. Mr.
29		Childs' term shall commence on the effective date of this resolution and ending on
30		April 17, 2011.
