

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY2009 Hikiwan District Administration Budget Modification No. 03)**

RESOLUTION NO. 09-223

1 **WHEREAS, the Hikiwan District presented its FY2009 Budget for District operations and seven**
2 **Communities in the amount of \$1,324,724.93; and**

3 **WHEREAS, the Tohono O'Odham Legislative Council Resolution No. 08-575 approved the FY2009**
4 **Hikiwan District Budget in the amount of \$1,324,724.93; and**

5 **WHEREAS, the Hikiwan District Council is now presenting budget modification No. 03 for FY2009**
6 **in the amount of \$18,342.56; and**

7 **WHEREAS, the District Administration inadvertently used the fringe benefit rate of 32% for**
8 **permanent employees of the District; and**

9 **WHEREAS, the correct amount for District fringe benefit rate is 27%; and**

10 **WHEREAS, the District Administration has corrected the fringe benefit rate from 32% to 27% for**
11 **the rest of the fiscal year 2009 which is a savings of \$18,243.56; and**

12 **WHEREAS, the funds for occasional appointments for laborer positions for the District**
13 **Administration's Housing Rehabilitation Program is being depleted; and**

14 **WHEREAS, the District Administration presented a proposal to modify the FY2009 District**
15 **Administration budget to continue the temporary laborer positions under the**
16 **Housing Rehabilitation Program as follows:**
