1 **WHEREAS, the Tohono O'odham Nation Police department (TONPD) has applied and**  
2 **successfully been awarded under the State of Arizona Department of Homeland**  
3 **Security the FY 2008 Operation Stone Garden Program grant; and**

4 **WHEREAS, the TONPD has been awarded under grant agreement no. 444411-03 the amount of**  
5 **\$336,000.00 for overtime expenses & mileage reimbursement and grant agreement**  
6 **no. 444411-04 the amount of \$125,450.00 for equipment; and**

7 **WHEREAS, this funding is for grant period of November 1, 2008 thru October 31, 2009; and**

8 **WHEREAS, the TONPD has budgeted these funds as required under 610.5 Other Compensation,**  
9 **620 Fringe Benefits to include the Public Safety Personnel Retirement System, 721**  
10 **Supplies other, 771 RM Vehicles and 750 Major Capital; and**

11 **WHEREAS, the total amount of this budget is \$461,450.00.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
13 **approves the waiver of the indirect cost of this grant and approves and authorizes**  
14 **this budget in the amount of \$461,450.00 for grant no.444411-03 and no. 444411-04**  
15 **for grant period November 1, 2008 thru October 31, 2009.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**  
17 **Chairperson and any designated official to expend and administer the budget as**  
18 **attached, provided that any amendments affecting the funds or funding level shall**  
19 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup>. Day**  
21 **of APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and [09]ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
23 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
