

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services Recovery
Community Services Program Budget Amendment #1 for Carry Over from year one)

RESOLUTION NO. 09-226

1 **WHEREAS, the Department of Health and Human Services, provides prevention services; and**
2 **WHEREAS, the Tohono O'odham Department of Health and Human Services submitted an**
3 **application to the U.S. Department of Health and Human Services/Center for**
4 **Substance Abuse Treatment for a Recovery Community Services Program grant to**
5 **provide peer-to-peer prevention programs to support individuals in recovery and**
6 **their families on March 31, 2006; and**

7 **WHEREAS, the Notice of Award was received for Fiscal Year 2007 on September 30, 2006 in the**
8 **amount of \$350,000 for the first year of a four-year grant; and**

9 **WHEREAS, the Notice of Award was received for FY 2008 on June 23, 2007 in the amount of**
10 **\$350,000 for the second year of a four-year grant, and**

11 **WHEREAS, the grant was awarded for the third year for FY 2009; and**

12 **WHEREAS, of the total grant amount of \$350,000 the budget proposed for Year Three reflects**
13 **19.35% in indirect costs; and**

14 **WHEREAS, a carryover amount from year one in the amount of \$111,270.00 was awarded on**
15 **February 25, 2009, a budget amendment is requested to increase the total award**
16 **amount to \$461, 270.00 in Fiscal year 2009; and**

17 **WHEREAS, the previous budget did not include line item 662 GSA Mileage and therefore we are**
18 **including into this budget amendment.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
20 **and authorizes expenditures in accordance with the FY 2009 Carry over from year**
21 **one of the Recovery Community Services Program grant, in the amount of**
22 **\$111,270.00. Increasing the total amount for Fiscal Year 2009 in the amount of**
23 **\$461,270.00. And add line item 662 GSA Mileage to this budget amendment.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Chairman, and any designated official to expend and administer the budget, as**
26 **attached, provided that any amendments affecting the funds or funding level shall**
27 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH. Day**
29 **of APRIL, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
30 **-0- NOT VOTING; and [09] ABSENT, pursuant to the powers vested in the Council by Section 1**
31 **(d)(2)(3)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**
