

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment No. 1 to Economic Development Governmental Relations  
Representation Contract)**

**RESOLUTION NO. 09-227**

1 **WHEREAS, the Legislative Council is vested with the authority to “consult, negotiate and conclude**  
2 **agreements and contracts on behalf of the Tohono O’odham Nation with Federal, State**  
3 **and local governments and other Indian tribes or their departments, agencies, or**  
4 **political subdivisions, or with private persons or organizations on all matters within**  
5 **the authority of the Tohono O’odham Council” (Tohono O’odham Constitution, Article**  
6 **VI, Section 1(f)); and**

7 **WHEREAS, by Resolution No. 08-318, the Legislative Council approved an Economic Development**  
8 **Budget (“EDD Budget”), which authorized the Chairman to administer the Economic**  
9 **Development Budget in consultation with the Economic Development Delegation; and**

10 **WHEREAS, the Legislative Council, by Resolution No. 08-352, approved a Governmental Relations**  
11 **Representation Contract with Triadvocates, LLC (“Contract”); provided that the**  
12 **Contract be funded from the EDD Budget; and**

13 **WHEREAS, the Commerce, Domestic Affairs, Appropriations, and Budget and Finance**  
14 **Committees, in consultation with the Chairman, the Office of Attorney General, and**  
15 **the Legislative Attorney, have recommended that Triadvocates, LLC perform**  
16 **additional governmental relations consulting services outside the scope of the EDD**  
17 **Budget; and**

18 **WHEREAS, the Commerce, Domestic Affairs, Appropriations, and Budget and Finance**  
19 **Committees, in consultation with the Chairman, the Office of Attorney General, and**  
20 **the Legislative Attorney, have reviewed, and recommend that the Legislative Council**  
21 **approve, the attached *Amendment No. 1 to Governmental Relations Representation***  
22 ***Contract Between the Tohono O’odham Nation and Triadvocates* (“Amendment No. 1”)**  
23 **for the period commencing April 1, 2009 and ending September 30, 2009.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby (1)**  
25 **approves Amendment No. 1 for the period commencing April 1, 2009 and ending**  
26 **September 30, 2009 in substantially the form attached hereto; provided that the**  
27 **additional services contemplated by Amendment No. 1 shall be funded from line item**  
28 **811 - Lobby from the FY 2009 Administrative Lobbying Provisions budget (No. 01-3002);**  
29 **and (2) authorizes the Chairman of the Nation to execute Amendment No. 1.**

5 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
6 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
