1 **WHEREAS, the Water Resources Department was created by Section 3301(A) in the Interim**
2 **Allottee Water Rights Code and by Council Resolution No. 07-485; and**

3 **WHEREAS, the Water Resources Department is requesting \$1,416,442.98 from the Southern**
4 **Arizona Water Rights Settlement Act Trust Fund for the FY2010 SAWRSA budget 21-**
5 **1525; and**

6 **WHEREAS, the Water Resources Department is requesting an in-kind match of \$8,158.00 from the**
7 **FY2010 SAWRSA budget 21-1525 for the Water Resources Department FY2010**
8 **Environmental Protection Agency Budget 11-5017; and**

9 **WHEREAS, the Water Resources Department FY2010 SAWRSA budget 21-1525 has been reviewed**
10 **by the Legislative Water Resources Committee and the Legislative Budget and Finance**
11 **Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **authorizes:**

- 14 **1. The appropriation and expenditure of \$1,416,442.98 from the Southern Arizona**
15 **Water Rights Settlement Act Trust Fund to the Water Resources Department FY2010**
16 **SAWRSA budget 21-1525, in accordance with the budget attached hereto.**
- 17 **2. An in-kind match of \$8,158.00 from the Water Resources Department FY2010**
18 **SAWRSA budget 21-1525 to the Water Resources Department FY2010 Environmental**
19 **Protection Agency budget 11-5017.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairman and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding levels of the**
23 **budget shall be submitted for further prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND Day**
26 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [04]ABSENT, pursuant to the powers vested in the Council by Article VI and**
28 **XVII Section 1(f) & (j) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**


