

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving carry over of unexpended FY 2009 funding for the Tohono O'odham Nation Fire Department for the Construction of a Permanent Facility)

RESOLUTION NO. 09-305

1 **WHEREAS, the Tohono O'odham Nation Department of Public Safety Fire Department has**
2 **deemed it critical and necessary to increase Fire Protection services to the Tohono**
3 **O'odham Nation, particularly the new Desert Diamond Casino/Hotel; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved a request of \$4,055,700.00 for the**
5 **construction of a permanent fire/police substation and other capital projects in FY**
6 **2008; and**

7 **WHEREAS, the actual construction of the proposed fire/police substation will not begin until FY**
8 **2010; and**

9 **WHEREAS, the Fire Department requires \$2,922,500.00 to fund the cost of construction during FY**
10 **2010.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
12 **approves carry over of unexpended FY 2009 funds in the amount of \$2,922,500.00 into**
13 **FY 2010, to construct a fire/police substation in accordance with the budget attached**
14 **hereto.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
16 **Chairman and any designated official to expend and administer the budget as**
17 **attached, provided that any amendments affecting the funds or funding level shall be**
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND. Day**
20 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI**
22 **Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
23 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


