8	WHEREAS, it is the recommendation of the Budget & Finance Committee to approve Amendment
9	#2 for the Gu-Vo Community amending justification.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
11	the Budget Amendment #2 for Gu-Vo Community amending justification of line item
12	852 Donation/Contribution, the original justification states:
13	"This line item will provide a \$150.00 donation to each community head of household
14	member for Thanksgiving & Christmas Holiday Dinner purchase, budgeted @\$150.00
15	per holiday x 2 holidays for 75 household members=\$22,500.00 (First Come First
16	Serve). Provide for the purchase of major appliances/furniture, including but not
17	limited to; TV, Entertainment System, and other household items, budgeted@\$800.00
18	per household x 57 household=\$45,600.00. The head of household must choose one,
19	either donation/contribution or building materials. \$2,387.98 is budgeted to purchase
20	storage for the Community."
21	And the amended justification that has been added is as follows:
22	"To provide a \$100.00 gift card to elders, including but not limited to the purchase of
23	food, clothing and kitchen or household items. On a first come first basis. And to
24	purchase storage shed, furniture, and appliances for the modular."
25	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
26	Chairman and any designated official to expend and administer the budget as
27	attached, provided that any amendments affecting the funds or funding level shall be
28	submitted for further prior approval by the Tohono O'odham Legislative Council.
