3 **meeting held on June 27, 2009; and**

5 **the justification to line item (750) Major Capital to include the purchase of a Van; and**


6 **WHEREAS, the Tohono O'Odham Legislative Council Budget & Finance Committee reviewed the**

12 **a van.**


13 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the**

20 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
22 **Stat. 984).**


