

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Frances G. Antone to the Indian Reservation Roads
Program Coordinating Committee)**

RESOLUTION NO. 09-476

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to consult "federal**
2 **agencies regarding federal activities that affect the Tohono O'odham Nation" and to**
3 **pass resolutions "to promote, protect, and provide for public health, peace, morals,**
4 **education and general welfare of the Tohono O'odham Nation and its members"**
5 **(Article VI, Section 1(f) and 1(c)(2) of the Constitution of the Tohono O'odham Nation);**
6 **and**

7 **WHEREAS, the Indian Reservation Roads ("IRR") Program Coordinating Committee provides**
8 **"input and recommendations to BIA and FHWA in developing IRR Program policies**
9 **and procedures" and supplements "government-to-government consultation by**
10 **coordinating with and obtaining input from tribes, BIA, and FHWA" (25 C.F.R.**
11 **§170.155(a)); and**

12 **WHEREAS, the Coordinating Committee consists of 12 tribal regional representatives (one from**
13 **each BIA Region), with one alternate tribal member for each regional representative,**
14 **provided that each "tribal representative must be a tribal governmental official or**
15 **employee with authority to act for the tribal government" (25 C.F.R. §170.155(b)); and**

16 **WHEREAS, Natural Resources Committee member Frances G. Antone was nominated in March**
17 **2008 to serve as the IRR Coordinating Committee Western Region tribal**
18 **representative, but she was not appointed until February 2009 and will therefore only**
19 **serve in that capacity for seven months (Resolution No. 08-150); and**

20 **WHEREAS, due to her expertise in, commitment to, and advocacy for tribal transportation,**
21 **Representative Frances G. Antone should be appointed to serve a full term on the IRR**
22 **Coordinating Committee.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

24 **(1) Nominates Representative Frances G. Antone, who is a tribal governmental official**
25 **with authority to act for the tribal government, to serve as the IRR Coordinating**
26 **Committee Western Region tribal representative.**

27 **(2) Requests that the Secretary of the Interior appoint Representative Frances G.**
28 **Antone to serve as the IRR Coordinating Committee Western Region tribal**
29 **representative.**

30 **BE IT FURTHER RESOLVED that the nomination made by this resolution shall supercede and**
31 **replace any previous Legislative Council nominations to the IRR Coordinating**
32 **Committee.**

33 **BE IT FINALLY RESOLVED that an appointment made pursuant to this resolution shall**

1 immediately expire if the appointee is no longer serving on the Legislative Natural
2 Resources Committee for any reason.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND. Day
4 of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 1,433.45 FOR;
5 957.35 AGAINST; 204.7[04] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the
6 Council by Section 1 (f) and (i) of Article VI of the Constitution of the Tohono O'Odham Nation,
7 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
8 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
9 of June 18, 1934 (48 Stat. 984).
