12 **accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH. Day**

14 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,390.8 FOR; -0-**

15 **AGAINST; 204.7 [03] NOT VOTING; and [01]ABSENT, pursuant to the powers vested in the Council**

16 **by Section 1 of Article II and Section of 1 (h) of Article VI of the Constitution of the Tohono**

17 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**

18 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**

19 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
