

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Gu Achi District FY 2009 Budget Amendments/Modifications for  
San Luis Community (Mod. #3) and the Gu Achi District Administration (Mod. #3))**

**RESOLUTION NO. 09-487**

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on September 14, 2009 to**  
2 **address issues pertaining to the Nation; and**

3 **WHEREAS, on September 4, 2009 at a regularly scheduled meeting, the Gu Achi District Council**  
4 **did approve budget modifications for San Luis Community (Mod. #3, Resolution #0909-**  
5 **089) and the Gu Achi District Administration (Mod. #3, Resolution #0909-093); and**

6 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review**  
7 **the communities' budget modifications submitted by the Gu Achi District and**  
8 **recommend for approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
10 **approve the Gu Achi District FY 2009 budget amendments/modifications for San Luis**  
11 **Community (Mod. #3) and the Gu Achi District Administration (Mod. #3).**

12 **BE IT FURTHER RESOLVED that the amendment/modification does not affect the overall portion**  
13 **of the Gaming Distribution of \$1,707,656.42 to the Gu Achi District.**

14 **BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>. Day**  
16 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
17 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
19 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**


