

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Accepting Tohono O'odham Department of Health and Human
Services, Division of Behavioral Health, FY2009 Methamphetamine and
Suicide Prevention Initiative (MSPI) Grant Award)

RESOLUTION NO. 09-488

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health provides**
2 **substance abuse, mental health, and prevention services; and**

3 **WHEREAS, the Division of Behavioral Health submitted an application to the U.S. Department of**
4 **Health and Human Services for a Methamphetamine and Suicide Prevention Initiative**
5 **(MSPI) grant award. The Nation was notified on June 24, 2009 the Behavioral Health**
6 **application was accepted for funding in the amount of \$300,000.00 and these funds,**
7 **included the 2008 funds were not made available to the Nation until June 2009, merely**
8 **four months prior to the expiration of FY2009. Therefore the funds have been given**
9 **prior approval to extend the utilization of the MSPI funds into FY2010. (See attached**
10 **letter.) The approved funding aims to increase the suicide crisis response capability**
11 **of the Tohono O'odham Nation by training gatekeepers in Applied Suicide**
12 **Intervention Skills Training (ASIST); and**

13 **WHEREAS, the \$300,000.00 grant is a Congressional allocation and therefore the funding is not**
14 **eligible for indirect costs as a condition of the award; and**

15 **WHEREAS, the Methamphetamine and Suicide Prevention Initiative (MSPI) grant for \$300,000.00**
16 **is hereby submitted for review and approval by the Tohono O'odham Legislative**
17 **Council.**

18 **NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 19 **1. The Legislative Council has reviewed, approved and accepts the FY2009**
20 **Methamphetamine and Suicide Prevention Initiative (MSPI) grant of \$300,000.00.**
- 21 **2. The \$300,000.00 is a Congressional allocation, and therefore the funding is not**
22 **eligible for indirect cost as a condition of the award.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level shall be**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH. Day**
28 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
29 **AGAINST; -01- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Section 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
31 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
