

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving to add 1 Eligible Adult Members to the Adult Master List for
Payment for the Fourth Per Capita)

RESOLUTION NO. 09-620

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**
3 **capita payments to the Nation's members provided that sufficient gaming revenues**
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**
7 **distribution payments in accordance with the Initiative (Legislative Council**
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Fourth Per Capita Revenue Allocation Plan per**
10 **Legislative Council Resolution No. 09-164; and**

11 **WHEREAS, the Secretary of the Department of the Interior did approve the Fourth Per Capita**
12 **Revenue Allocation Plan on June 15, 2009; and**

13 **WHEREAS, the Enrollment Program has submitted to the Tohono O'odham Legislative Council**
14 **the Certification Listing for eligible adult members for review and approval for the**
15 **fourth per capita distribution; and**

16 **WHEREAS, pursuant to Resolution No. 09-428 which approved the Master List for certification,**
17 **the initial number of verified adult eligible members for the fourth per capita**
18 **distribution is 19,141; and**

19 **WHEREAS, the Enrollment Program has identified 1 eligible adult members who was left off the**
20 **Adult Master Listing for the Fourth Per Capita Payment; and**

21 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**
22 **verification of a member and further certification by the Tohono O'odham Legislative**
23 **Council.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
25 **approves to add the attached list of 1 eligible adult members whose names were left**
26 **off the Adult Master List and such names will be incorporated into the Adult Master**
27 **Listing previously approved by the Tohono O'odham Legislative Council in Resolution**
28 **No. 09-428.**

29 **BE IT FURTHER RESOLVED that any eligible names identified in the future will be added to the**
30 **Adult Master List contingent on verification and certification by the Tohono O'odham**
31 **Legislative Council.**




