7	WHEREAS,	it is in the best interest of the Nation to continue representation by the Attorney; and
8	WHEREAS,	the Human Resources Officer and the Attorney General recommend an Attorney
9		Contract with the Attorney in the amount of \$15,000 for the period of October 1, 2009
10		through September 30, 2010; and
11	WHEREAS,	the 401(K) Trustee budget has sufficient funds for the contract amount; and
12	WHEREAS,	the  Human Resources Development Committee, the Domestic Affairs Committee and the  Committee  and  Committ
13		the Budget and Finance Committee recommend approval by the Legislative Council
14		of the Attorney Contract.
